He has several concerns for the subdivision which includes the painted lines on the roadway, the drainage ditch, lack of lighting, and a need for speed bumps. Mayor Wyatt and council explained how the Town of Resaca can help by possibly having an officer come through and

write tickets but the speed bumps are no longer allowed on the roadway. The drainage ditches may be located on private property and if that is so then the Town cannot trespass. The lighting may be a state issue and Mayor Wyatt will have Councilwoman Adams look into that. Also, the painted lines may be considered a state issue and will have to look into that as well. Mayor Wyatt closed the floor for discussion.
